

1. A hearing shall be held on the 28th day of November, 2022, at 9:30 A.M., in Courtroom 450, Bucks County Justice Center, Doylestown, Pennsylvania regarding the Petition; and
2. Proof of such service shall be filed not less than 20 days prior to the date set for hearing and shall be available for inspection by the Court at the time of hearing. This Order shall be posted prominently in the main office location of the Penridge School District upon receipt, and a copy of the Petition previously served upon the Respondents shall continue to be maintained and available for inspection at said office.
4. Notice of the above hearing shall be published in accordance with Bucks Co. R.C.P. No. *285 not less than 7 days prior to the date set for hearing, and proof of publication shall be filed and available for inspection by the Court at the time of hearing.
